A minimum of 1 hour per person will be invoiced for the use of Westport personnel.

A minimum of 3 hours per person will be charged for work performed after 15:00. on weekdays, or at any time during weekends and public holidays.

In addition, in the event of such a call-out, Westport's customers will be charged for the contractually agreed rest hours on the following working day. The standard rate applies, cf. the Working Environment Act § 10-8 (1).

The capacity of the machines is in accordance with each machine's individual load chart. Westport AS reserves the right to carry out work using the type of machine that is most suitable based on the nature of the work and the availability of equipment. Billing is based on each commenced hour.

The stated prices for transport equipment are exclusive for crane operators and machine operators, who are invoiced in addition, in accordance with section 3.2.

Equipment required to meet port regulations is invoiced for a minimum of 2 hours. All other transport equipment is invoiced for a minimum of 1 hour. Preparation of the equipment is included in the rental period.

If Westport needs to rent additional equipment or third-party services, these will be invoiced at actual cost plus 25%

Transport equipment may also be rented at specially agreed prices for specified time periods.

3.5 Port call fees

The port dues are the vessel's payment for the use of the fairway and are payable for each call within the port district. The port dues are collected by the public port authority, or by a terminal operator on its behalf, according to the rates in effect at any given time.

3.6 Berth rental

Berth rent is the vessel's payment for the use of quays owned or operated by Westport. Westport reserves the right to instruct vessels to shift to other quay areas, at their own cost and risk. Berth rent is collected from the vessel's agent or forwarder upon invoice from Westport.

4. PORT FEES

4.1 ISPS Fee

At security level 1, an ISPS fee of 30% of the berth rental will be charged.

4.2 Cargo dues

All goods passing over Westport's port facilities are subject to cargo dues, calculated based on the weight of the goods in metric tons (M/T).

Cargo dues are collected from the shipping company, or from the vessel agent or freight forwarder, upon invoice issued by Westport. The shipping company or its agent is responsible for ensuring that Westport receives a copy of the vessel's manifest or cargo list containing the necessary information regarding the consignee/shipper and the cargo's dimensions and weight.

Westport AS may require that cargo dues be paid in advance of the vessel's loading or discharge operations.

4.3 Delay and Cancellation Fee

Gang ordering procedure

1. Lines must confirm vessel ETA and gang request by 12:00 on the calendar day prior to operations. More advanced confirmation is required for vessels arriving on public holidays or on the day following a public holiday.

Gang orders for vessels arriving within contracted and agreed berthing windows will be confirmed by 14:00 on the business day prior to operations. Gang orders for vessels arriving outside of agreed windows will be provided as soon as appropriate labor can be identified.

Cancellation of confirmed Gangs: Cancellation of gangs after gangs are confirmed are subject to the following cancellation charges, if outside agreed berthing window.

Documentation and Cargo cutoffs/Electronic communication

1. For services or operators that cannot provide COPRAR files, a fee per vessel call will apply. Failure to send information prior to the cutoff (12 hrs) may result in delayed start of operations and associated waiting time charges. Export booking information must be supplied via COPARN messages or alternatively manual updates via the Westport Moss customer portal.
