## 1. GENERAL CONDITIONS

<b>General</b>	Unless otherwise agreed, the prices, terms and conditions according to this pricelist shall apply.
<b>Prices</b>	All prices are in NOK exclusive of VAT. Prices can be changed without further notice.
<b>Payment</b>	The payment terms are per 15 days. In cases of late payment, an interest on overdue payment of 1,5% will be added per month or part of the month. For short time lease, Westport AS can ask for advance payment.
<b>Hired services/ Expenses for customers</b>	Hired services performed by Westport AS will be charged at actual costs with an addition of +25%.
<b>Delivery</b>	All prices are based on delivery in the harbor.
<b>Equipment</b>	Lease of equipment does not include operator unless specifically agreed.
<b>Smart Harbour</b>	Westport AS has established Smart Harbor to make sea transport more attractive. We collaborate with Proximity, which delivers the technology. Westport encourages all our customers to connect to Smart Harbor.
<b>Public Holidays</b>	<p>New Year's Day, Maundy Thursday, Good Friday, Easter Eve, Easter Sunday, Easter Monday, 1<sup>st</sup> of May, 17<sup>th</sup> of May, Ascension Day, 1. Pentecost, 2. Pentecost, Christmas Day, Boxing Day.</p> <p>For Christmas- and New Year's Eve and Wednesday before Ascension Day, special rates will apply.</p>
<b>Liability</b>	<p>Unless specifically agreed, Westport AS will not be liable for any loss of or damage to goods and/or equipment belonging to customers which are in Westport AS custody and/or handled by Westport AS, unless the loss or damage is caused by gross negligence by Westport AS.</p> <p>In exceptional cases where customers or others are using Westport AS equipment, documentation or certification for use of such equipment has to be provided. Westport AS shall be indemnified for all such use of equipment.</p> <p>Any loss or damage has to be reported to Westport AS immediately and latest within 2 weeks after the loss or damage occurred. Westport AS can, at customers cost, assist with obtaining additional insurance for customers if necessary.</p>

Minimum lease is 1 hour. For call-outs outside office hours, weekends and public holidays, a minimum of 3 hours per person will be charged.

Machinery will be charged for minimum 1 hour, except harbor crane which is charged for minimum 2 hours.

In addition, customers will at such call-outs be charged for mandatory off time the following day according to the Work Environment Act § 10-8 (1).

Labor can also be hired at specifically agreed prices at specified times.

Hire of additional equipment will be charged at actual cost + 25%.

## 4. HARBOUR FEES AND TARIFFS

Harbor tariff for Westport AS valid from  
1. January 2024



### 1.0 PORT FEE

Port fee is the vessels payment for usage of ports and fairways and is paid per docking in the area. The port fee is collected by Greater Stavanger Port Authority according to current pricelists.

### 2.0 QUAY DUES

Quay due is the vessels payment for the use of the quays owned or operated by Westport AS. The vessels quay time is estimated from the time the vessel docks and until it leaves the quay, including the time of pulling the vessel to a new quay. After the first 24 hours, a part of a day of 6 hours or less is considered half a day. Westport AS holds the right to instruct vessels to be pulled to other quay areas for its own cost and risk. Quay dues are billed from Westport AS to the vessels agent or freight forwarder.

#### 2.1 Tariff for quay dues

The tariff for quay dues is valid for Westport AS;

Lowest fee is 5537,- Per 24 hrs

### 3.0 USE OF QUAY AREAS (CARGO DUES)

Westport AS has established that all goods moving over our quays is to be charged with a cargo due. The cargo due is calculated in metric tons (MT). Cargo in volumes is calculated to weight where 1m<sup>3</sup> is no less than 0,5MT. For cargo that is loaded directly from ship to ship without touching the quay, a cargo due of 50% will be charged. Cargo dues are invoiced from Westport AS to the vessel owner, its agent or freight forwarder. The vessel owner or its agent is responsible for delivering a copy of the vessels manifest or cargolist with adequate information about the recipient/sender and the cargos measures and weight to Westport AS.

Westport AS can require that the cargo due is paid in advance of discharge or loading of vessels. Westport AS maintains the right to take necessary actions towards the captain of the vessel, its agent or freight forwarder to ensure correct information regarding the basis for estimating the cargo dues.

#### 3.1 Tariff for cargo dues

Unless otherwise agreed, the following prices will be charged for cargo dues at Westport AS;

##### Type of goods

Fixed cargo due NOK 45,- pr.M/T

Reloading fee NOK 45,- pr M/T  
Provided that the reloading is done within 48 hours.

Other types of goods according to agreement.

### 4.0 STORAGE OF GOODS

Storage of all types of goods at Westport AS are only allowed at designated areas and in agreement with Westport AS.

If the agreed storage time cannot be extended, stored goods have to be moved as soon as possible by the end of the agreed storage time. Goods that are stored without agreement with Westport AS, or that are stored longer than the agreed storage time, can be moved and stored at a different place for the customers cost. If such goods are not collected within 9 months, Westport AS holds the right to sell such goods at public auction or after regular advertising.

Westport AS holds the right to sell such goods before 9 months if;

- (i) the value of the goods does not cover the accrued costs, or
- (ii) the goods is easily perishable, or
- (iii) the goods can cause damage.

Westport AS can after its own judgement improve the packaging or repack such goods at the customers cost and risk.

Westport AS does not without further agreement accept any liability or commitments for any goods that are stored in our areas.

#### 4.1 Tariff for storage of goods

Goods that are left/stored at quay areas belonging to Westport AS will be charged according to the following tariffs:

2-30 days NOK 26,10 pr.m<sup>2</sup>/day

Over 30 days NOK 388,- pr.m<sup>2</sup>/day

Or according to agreement.

### 5.0 SPECIAL CONDITIONS FOR OPERATIONS WITHIN STAVANGER AND SOLA HARBOURDISTRICT

Special conditions for operations within Stavanger and Sola Harbor district may apply for operations in Westport AS harbor area.
